TERMS AND CONDITIONS :

1. Interested Firms/persons may inspect the said vehicles physically on any working days from Monday to Saturday (except Second Saturday) between 02.00 PM and 05.00 PM at the above mentioned office premises.
2. The disposal of vehicles shall be strictly on "AS IS WHERE IS BASIS" and no guarantee of quality or certificate of its worthiness will be given by this Office.
3. Firms/ Persons who are interested to participate in the auction should deposit EMD amount of Rs.2,000/- (Rupees two thousand only) in the form of DD/Banker's Cheque only drawn in favour of Director, NSSO, Chintamani on or before 20.08.2025 at 11.00 AM and obtain proper acknowledgement. The EMD will not be accepted beyond the prescribed date and time and will not bear any interest.
4. No parties will be allowed to participate in the public auction without submission of the required EMD.
5. EMD of the First, Second and Third highest bidders will be retained by this office till the disposal of the vehicles to the successful bidders. The EMD of other unsuccessful bidders will be refunded immediately after lifting of the condemned vehicles by the highest bidder.

6. The successful bidder should deposit 25% (Twenty five percent) of the bid amount on spot either in cash or in the form of DD/Bankers/ Cheque drawn in favour of Director, NSSO, Chintamani. The balance amount should be deposited within 03 working days after completion of the auction in the same form of payment. If he fails to deposit the balance amount within the stipulated time of 3 working days, the 25% amount so deposited will be forfeited along with the E.M.D.

7. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of his/their residential status (Ration Card/Voters Identity Card or Aadhar Card/PAN etc. in case of individual and Registration Certificate in case of firms etc.).

8. The disposed vehicles should be taken by the successful bidder(s) within 48 hours of depositing the money at their own expenses at working hours. No assistance/Transportation will be provided by this Office. Permission to take out the disposed vehicles from SSPC premises will not be allowed on General Holidays, Second Saturday & Sundays. The liability towards transportation, taxes etc. shall rest with the bidder.

9. The bidder has to provide his full Name/Name of the authorized signatory of the Firm/Name of Father, Full Postal Address, Telephone/Mobile No. before participation in the auction process.
