1. Dried Trees will be disposed off on **"AS IS WHERE IS CONDITION"**.
2. Interested parties can inspect the dried trees at the office premises from **September 6, 2025, to September 25, 2025**, between **10:00 AM and 4:00 PM** on working days.
3. The interested participating bidders are required to be present at **"Office of the Scientist-B, CSB - P2 Basic Seed Farm, NSSO, Gavimata, Kapanahalli, Ballekere POST, K R pet Taluk - 571426"** on or before **10.30AM on 26-09-2025**.
4. Those who are interested to participate in the public auction should deposit Rs.1,000/- (Rupees One thousand only) by cash as EMD on spot before 11.00 AM of **26-09-2025**.
5. No parties will be allowed to participate in the Public Auction without payment of required EMD.
6. EMD of the First, Second and Third highest bidders will be retained by this office till the disposal of the dried trees to the successful bidder. The EMD of other unsuccessful bidders will be refunded after completion of Auction process. EMD will not carry any interest. 11. All dried trees listed for auction has been fixed with a Minimum floor value and in the event that any particular lot does not fetch the Minimum floor value, the highest bid will be evaluated by the committee and thereafter the decision will be communicated.
12. The highest bidder has to lift the auctioned dried trees from the said premises within 06 (Six) working days at their own cost and no assistance / transportation will be provided by this office. The unit is not responsible for any untoward incident once the articles are handed over to the highest bidder.
